This document does not remove any statutory obligations of Mullaloo Longboarders Inc. nor does it seek to exclude potential liability for gross negligence. The intent of this document is to set out the terms of agreement between the participant or their parent/guardian and Mullaloo Longboarders under which the participant acknowledges and accepts the inherent risks in the sport of surfing and associated activities and that they voluntarily assume those risks.

Mullaloo Longboards Inc. PARTICIPANT CONSENT, WAIVER AND RELEASE FROM LIABILITY

I acknowledge that participating in activities sanctioned by Mullaloo Longboarders Inc. or their affiliates (including associations and clubs) involves a risk of personal injury or death to me and damage to property belonging to others and me. I knowingly and voluntarily agree to the terms and conditions outlined in this document.

In exchange for being permitted to participate in Mullaloo Longboarders Inc. sanctioned events in what ever form they take, and having the opportunity to obtain representative selection, win trophies, rewards and prizes, I warrant and covenant that:

I am in good health and have no physical conditions that affect my ability to participate in any Mullaloo Longboarders Inc. sanctioned event and have not been advised otherwise by a medical practitioner.

I will immediately advise Mullaloo Longboarders Inc., and its affiliates if I observe or otherwise become aware of any unsafe condition with grounds, facilities or equipment;

I assume all risks associated with my participation in any Mullaloo Longboarders Inc. sanctioned event including without limitation the risk of any negligence or recklessness by other participants. I understand that there may be risks involved which are not known to me or to Mullaloo Longboarders Inc., or its affiliates, sponsors or volunteers, and may not be foreseen or reasonably foreseeable by me or any of them at this time or at the time of the activities in which I may participate and agree to assume such unforeseeable risks.

I agree to indemnify, defend and hold harmless Mullaloo Longboarders Inc., and its affiliates, employees, agents and volunteers from and against any claims, causes of action, damages, judgments, liabilities, fees (including legal fees), costs and expenses incurred by Mullaloo Longboarders Inc., and its affiliates as a result of my unlawful actions or failure to act during any sanctioned event.

I agree to conduct myself in a professional manner and treat all colleagues, officials and spectators respectfully. I realise that if disciplinary action is taken against me, I may NOT be entitled to representative selection, trophies, rewards or prizes and I may be suspended from the sanctioned event or future events.

I agree to abide by the respective Constitutions, Policies, Playing and Championship

Rules of Mullaloo Lonboarders Inc. and its affiliates and authorised instructions issued from time to time by any authorised Official of Mullaloo Lonboarders Inc., and its affiliates.

This document and its terms are **legally binding** and will be construed to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions found to be unenforceable shall not affect the validity or enforceability of any other provisions, which may be modified by a court having jurisdiction.
